- (d) Legal structure: PRS is a private company limited by guarantee.

Governance structure: PRS is run by a Members' Council ("Council") responsible for the governance of the company in line with its Articles of Association and Rules & Regulations. The Council and Council Members constitute respectively the Board and Directors of PRS for all company law purposes and, collectively, the supervisory function under regulation 8 of the Collective Management of Copyright (EU Directive) Regulations 2016. The Council comprises 25 Council Members appointed by the membership - 10 writers, 10 publishers, 4 independent non-executive Council Members and one executive Council Members, the Chief Executive Officer. The Council mandates certain authorities to: the Board of PRS for Music Ltd (a wholly owned subsidiary company and the operating company of PRS); the Audit Committee; the Nomination Committee; the Conflicts Committee; the Distribution Committee; and the Licensing Committee.

Those procedures assist the directors of Performing Right Society Limited (the "company") in fulfilling its obligation to report under section 21(2)(b) of the Collective Management of Copyright (EU Directive) Regulations 2016. Their audit report is included as an appendix to this report.

Part 2 - Explanatory Notes

- [1] Indirect costs have been allocated using an activity based costing model. PRS incurs direct costs relating to mechanical licensing which have been excluded from the ATR report on the basis that mechanical collections and costs are not reported within the PRS ATR. The social and cultural deductions have been excluded from costs as shown separately in the deductions section. There are no operating and financial costs with regard to "services other than the management of rights but including social, cultural and educational services" in accordance with section 21(4)(i)(iii) of the Regulations.
- [2] Gross distributable income excludes interest and the deductions for social and cultural purposes, and is calculated as gross collections less direct and indirect costs for the reporting year. This is different to Distributed amounts which reflects the amounts distributed during the year which will include amounts collected in prior years.
- [3] The distributions reported are adjusted to include distributions relating to PRS repertoire paid directly to PRS members by joint venture partners or other Collective Management Organisations ("CMO").
- [4] Administration deductions are applied to the gross income of the Society in accordance with, and as permitted by, Rule 2(c) of PRS's Rules and Regulations: The administration deductions are expected to cover the direct costs of the company.
- [5] Cultural deductions are donated to the PRS Foundation, which is further explained in their Annual Report. No deductions are made for educational purposes. In 2022, in order to meet pre-existing commitments to this charity, these deductions were taken from two sources, neither of which can be reported by type of use: (1) non-licence revenue not due to foreign societies (i.e. investment income) and, to the extent that that such investment income was insufficient to meet the commitment, from (2) PRS's own reserve fund as per Article 58(b).
- [6] Gross Income excludes Non-Licence Revenue which does not relate to royalties received. This has been incorporated within "Other Income".
- [7] Total UK Joint Ventures represents the financial performance of International Copyright Enterprise Services Limited (ICE Services), Solar Music Rights Management Limited (Solar) and PPL PRS Ltd as reported in the Financial Statements of those companies. Gross income relates to commission or service income.
- [8] "Other Income" includes amounts received from 3rd parties in relation to the provision of services, predominantly related to mechanical rights, which have been netted off against costs as per explanatory note 1.
- [9] This category comprises monies that have been collected by PRS in the financial year that are being processed for distribution in the next applicable distribution cycle.
- [10] 'Rights & Ownership Issues' includes where the work is the subject of a dispute between rightsholders, or the member has died and PRS is holding unpaid distributions pending confirmation of a successor; in either case the attributed royalties will be held until such time as the dispute is resolved or the legal process complete. Generic hold is also captured in this category. This covers cases where PRS has suspended payment of distributions to a member for legal, regulatory, or other reasons. In such cases, no sums will be paid to the member (or third party, where relevant) unless and until PRS is ordered to or is otherwise satisfied that it can release the amounts concerned. Sums relating to the use of *Un-notified works* is also included in this category. Un-notified works refers to those instances where PRS has received usage data with the title of work and the writer details, but we are not able to match that information to a work on the database, most commonly because the writer (or publisher on their behalt) has yet to register their interest in the work with us. Once notified of the claims against the work(s), PRS will pay the writer share to the named writer or to an Affiliated Society, as the case may be. The publisher share will be held until the necessary details are confirmed. If no publisher registers a claim against that work in the following three years, PRS will treat the work as "unpublished" for distribution purposes and pay the money to the writer(s)/Affiliate.
- [11] 'Non-PRS member': Includes cases where money has been paid to PRS by another Society but when processed on the PRS systems, the member(s) is found to not be PRS. The money will be returned to the originating Society when PRS makes its next distribution to the society in question. It also captures *Terminated*: If a member has decided to leave PRS, royalties due to them may still be paid to PRS after they have left. These sums will either be returned to the society concerned on on onwards to the new CMO. Where the member has not joined another CMO, PRS will pay the sums to the former member if they relate to performances of that member's works prior to the date on which membership ended.

Part 2 - Explanatory Notes (continued)

- [12] 'Pending Rightsholder Financial Information' encompasses: Awaiting tax information from other collection societies: PRS needs the Affiliated Society to supply tax residency details of their members so that the correct tax treatment can be applied in fulfilment of our legal obligations; Failed bank credit: where the wrong bank details have been provided or the member has changed bank without notifying PRS, the money is returned to PRS. However, the bank cannot direct PRS to the new bank, the information must come from the member. Pending telegraphic transfer set-up: telegraphic transfer is an electronic method of transferring money, most commonly used for international transactions. Where there are certain bank details missing, this process may be delayed. No payment details or address: where a member has registered but has not provided PRS with sufficient information to make a payment.
- [13] 'Other': includes sums that are too small to be paid out at that time, and cases where the member has received an advance and under the published scheme PRS retains monies to recoup that amount.
- [14] The amounts in this category will have been delayed due to objective reasons that prevent their distribution i.e. data availability or completeness, distribution policy or online residuals.

Data issue: If the usage data associated with a work received from the licensee is incorrect or incomplete, PRS may not be able to distribute until the data is received in a complete and usable format.

Policy issue: PRS has a rigorous distribution policy-making process. There may be instances where it is not clear from the existing distribution policy how to distribute certain sums. This might be because a new licensing scheme has been introduced and there is no existing policy basis on which to distribute the relevant royalties, or there is a new licensee from whom PRS has not received adequate usage data against which to distribute the royalties concerned. PRS therefore needs time to formulate and follow the governance processes necessary for directors to agree and approve the associated distribution policy.

Residuals: This category relates to multi-territory online licensing (MTOL) revenues only. We use the term residuals to describe money for an MTOL license which has not been matched to a registered work, shares on a matched work or subsequently claimed by a member. When we have determined that no further claims will be made for a period and as such the residuals are available for distribution, a policy decision is needed to determine how to distribute the residuals across identified works for the service and which usage period should be used (ie which data set).

- [15] Where PRS has been unable to identify one or more of the rightsholders within three years from the end of the financial year (31st December) in which the royalties for the use of the works concerned were collected, the royalties not falling within the categories described above are deemed to be "non-distributable". It is the policy of PRS to not hold any non-distributable amounts as any amounts for which right holders cannot be identified after three years are distributed pro-rata in accordance with Rules 2(gb) and 2(gc) of PRS's Rules and Regulations, unless prior to such distribution the PRS Members' Council directs that the whole or part of such sums be applied for the purposes of supporting PRS social, cultural and/or other object specified in Article 58 of PRS's Articles of Association. The PRS Members' Council did not make such a direction in 2022 and, as a result, this report does not contain an analysis of transfers from non-distributable income to distributable and/or other PRS-Constitutional purposes as the case may be.
- [16] £27.2m royalties from international territories that PRS manages itself and cable and satellite re-transmissions, which PRS administers and distributes on behalf of other societies, are not included in the 'CMO report'. These royalties are included within International gross income disclosed in the 'Part 3 Financial Information'.
- [17] Gross Income relating to amounts received from other CMOs in the CMO report appendix, is defined as the amount received from a CMO net of the local CMO administrative deductions.
- [18] Where Net Income distributable to other CMOs in the CMO report appendix includes amounts that have been allocated to other CMOs but are not yet distributed to other CMOs, this is due to objective reasons such as the need for further information or documentation to complete payment.
- [19] Amounts paid direct by PRS to members of other CMOs. There is no administration deduction applied by PRS for these payments.
- [20] The resources used to cover costs are the income from rights management. Section 21(4)(i)(iv) of the Regulations requires disclosure of these resources. This has been interpreted as disclosing the deductions for administration, as presented on page 3.

Opinion
