



# Limited Online Music Licence (LOML)

## Who needs this licence?

Small digital services in the UK that offer on demand streaming, permanent downloads, podcasts, webcasting and general entertainment content to a UK audience. We categorise services as small if their annual gross revenue is less than £12,500.

## What this licence covers

LOML covers the communication to the public and associated mechanical rights (excluding synchronisation) of our members' repertoire through digital services.

## How do I apply?

Visit [prsformusic.com/loml](http://prsformusic.com/loml) to register your details and apply for a licence. You can pay with a credit or debit card.

## What are the licence fees?

Fees are based on how much music a service uses. Prices start from £138 + VAT for a 12 month licence.

## Reporting requirements

You need to tell us how much music you used at the end of each licence period. We can top up your licence if you underestimated your level of music usage at the start of the licence year.

- Synchronisation rights
- Use of music in adverts, sponsorship or corporate videos
- Adaptations of works

## Choose the right licence for your service

	<b>Music download</b> Services that allow users to download permanent copies of musical works.
	<b>Music on demand</b> Services that allow users to select individual musical works on demand.
	<b>Interactive webcast</b> Services that allow users to listen to a music based webcast. Users cannot select individual musical works to listen to but they can pause and fast forward the webcast.
	<b>Webcast</b> Services that allow users to listen to a music based webcast. Users cannot select individual musical works to listen to, pause or fast forward the webcast.
	<b>General entertainment</b> Services that allow users to download or stream general entertainment audio visual content, e.g. TV programmes or films which include music, but not as the main focus.

# Licence fees

## Please note:

A service providing two or more music service types require a licence covering each individual usage.  
e.g. A service providing up to 2,200 downloads and 60,000 streams would be calculated as follows:

**Music Download - Band A = £138**

**Music on Demand - Band B = £274**

**Total Licence fee = £412 + VAT**
